REMEMBER ON COLLECTION DAY

- ltems placed outside of carts will not be collected.
- Your carts should be placed outside no later than 6:30 am on collection day.
- Carts should be positioned on top of your curb with the handles and wheels facing towards your home.
- Place carts side-by-side approximately 1 foot apart & at least 3 feet from any obstruction (i. e. fire hydrants, trees).
- Carts should be removed from the curb within 12 hours after service.

TEMPORARY COLLECTIONS

Larger waste collection containers (from 3 yard to 40 yard) are available for clean-up and remodel projects. Temporary 3 yard clean up bins for excess green waste are available at a discounted rate.

BULKY ITEMS

Items that cannot fit in your automated carts are considered bulky items. Bulky items must be manageable by a two-person crew. Common bulky items include:

- Couches
- Desks Mattresses
- Chairs
 Excess Green Waste

WHITE GOODS HOUSEHOLD APPLIANCES

Household appliances containing Freon and other white goods cannot be placed in your automated carts. CR&R will collect white goods from your curbside, as a bulky item. Examples include:

- Refrigerators
- Freezers
- Dishwashers
- Washers or Dryers
- Ovens
- Air Conditioners
- Stoves
- Water Heaters

E-WASTE

Electronic Waste (e-waste) is anything with a circuit board or battery. It is illegal to dispose of e-waste in any of your automated carts. CR&R will collect and legally dispose of and recycle these items. Examples of e-waste include:

Monitors

- MP3 Players/Stereos
- Microwave Devices
- Computers/Laptops
- Televisions
- VCRs/DVD Players
- Printers/Scanners
- Computer Peripherals
- Digital Cameras
- Cell Phones

Copiers

Keyboards

You are eligible for **free** bulky item collection two times per year, up to four large items per pick up.

HAZARDOUS WASTE


Household Hazardous Wastes (HHW) are products that are flammable, corrosive, reactive or toxic. They are dangerous to the public and environment. It is illegal to dispose of HHW in any of your automated carts.

All HHW must be taken to a county-operated collection center. Examples include:

- Automotive Fluids
- Propane
- Cleaning Products
- Medical Waste
- Paint & Solvents
- Batteries

- Pesticides, Fertilizers
 & Herbicides
- Pool Chemicals
- Non-Empty Aerosol Cans
- Fluorescent Bulbs
- The nearest centers are located in the Cities of Anaheim and Irvine.

ROSSMOOR COMMUNITY COLLECTION PROCESS

You may place a mixture of all items in your carts. Our trucks collect your waste and transport it to a Materials Recovery Facility (MRF) where all recyclables are pulled from the waste stream through a process of manual and mechanical sorting.

STEP

Waste materials are placed in carts that will be provided by CR&R or collected through special Bulky or E-waste pick up.



In order to increase Community Recycling and diversion, bag the following items separately and place them in your cart:

- Wet waste
- Used clothing and shoes

STEP

2

Waste and recyclables are collected and transported to the MRF.



CR Transfer MRF

Our trucks collect the waste from the carts in your community and transport it to a Materials Recovery Facility (MRF). Once the MRF receives the transported waste, recyclables are pulled from the waste stream through a process of manual and mechanical sorting. These combined processes ensure that the maximum amount of recyclables are recovered from your waste stream and kept out of Orange County's Landfills.

STEP

3

Processed recyclables are separated by commodity and baled.







STEP

4

Thousands of bales are shipped to locations for further processing or to various markets.

Post consumer items such as paper products and clothing are made from various recycled materials.
