- Park Hours are from 7 a.m. to 10 p.m.
- All space is available on a First-Come-First-Served Basis. Residents may reserve Picnic Areas (see fee schedule)
- Groups of 50 or more must come to the RCSD Office to fill out a no-cost User Permit and provide evidence of insurance.
- No Commercial Solicitation, Sale of Merchandise/ Service or Distribution of Advertisements is allowed without prior written permission from the RCSD.
- Jumpers/Bouncers require a Special Use application and a \$1 million dollar insurance policy.
- No Skateboarding
- No Golfing
- Vehicles are allowed in designated parking lot area only
- No Smoking or Alcohol permitted in ANY of our Parks
- Possession/Discharge of a weapon(s)/firearm(s) is strictly prohibited
- No Amplified Sound
- Pets must be leashed at all times
- Pick up after your leashed pets
- All Trash must be secured in plastic bags and placed in outside receptacles
- Wednesdays are scheduled for mowing lawns which may restrict the use of the parks for some events.
